## Public Hearing #1:

Mayor Tobin opened the Public Hearing at 7:00 PM to hear comments on the proposed new Zoning update.

Bruce Tytler – Expressed being in support of the proposed changes citing the diversity that exists in the neighborhood. Believes that the proposed changes will further help to stabilize the neighborhood.

Lorraine Karpowich – Read the proposal and believes the proposal to be detrimental to her property. Expressed concerns over 300-63, Section D, 2.1 stating that her property would be determined by City government and that the implications the provision has on potential buyers is limiting thereby imposing harm on tenants. Alleged policies exemplify government abuse.

Tom Larson – In favor of the proposed changes. Has experience with zoning in agriculture. "Falls into down zoning"- restricting areas for specific use. Stated that the measures would be limiting to potential buyers, and that the zoning could be redirected to pursue better economic initiatives.

Laura Gathagan – Aware of the limitations on selling to potential buyers. Believes that property values will increase with these potential changes. The neighborhood needs to be residential.

Rich MacDonnell – Opposed to the proposed zoning measures. Wants to sell to whomever can afford to pay the most.

Kevin Halpin – Opposed to the measures. Does not think that government should have right to dictate to whom he can sell his home. Has personal interest as property is affected by the proposed provisions, and believes that provisions will negatively affect his financial future and will seek to sell his property immediately.

Steve Muka – We have high property tax in Cortland, and zoning presents a unique opportunity to change. Property owners can ask for change to zoning to develop property. States that due to ambiguities relating to the term "grandfathered", the properties on the hill are illegal due to over-occupancy.

Robert Stacy – Expressed concerns over enforcement of the Code. Believes that stronger enforcement of the Code would solve the problem and that law-abiding citizens should not be punished.

Abi Cleary- Close to retirement and lives on the hill. Worries about selling her house due to current climate seeing property values decreasing.

Mayor Tobin closed the Public Hearing at 7:30 PM.
