<u>Public Hearing 1:</u> Public Hearing on amending Code section 107 regarding registration of Vacant Buildings.

Jo Schaffer spoke stating there has always been a safety issue. It is a single lane street and needs to be defined as one way.

Penny Pozella spoke stating she understands the need to limit traffic. Has never experienced heavy pedestrian traffic and there is a sidewalk the kids can use. She agrees with eliminating the right hand turn on to Otter Creek from Groton. There is a possibility of congestion on Groton Avenue. People may speed more coming from Townley to Groton Avenue.

Jim Place spoke stating he lives on Pine Crest. He has concerns with traffic at Groton Avenue and Townley. Possibly paint a white line along edge of the road to help cars.

Christine Place spoke stating she lives on Pine Crest. There is huge amount of traffic with students and staff. Eliminating left turns on to Groton from Otter Creek is a good idea. It should be more of the number of cars on the street, not just speeding.

Angela Gellatly spoke stating she lives on Otter Creek. There has been a traffic study. There are aggressive drivers because of the narrow road.

Public Comments:

Mecke Nagel spoke about environment safety specifically reminding everyone that we live on sole source Aquifer. We need to be good stewards. One step to protecting the aquifer is to ban pesticide spraying. Another aquifer issue is fireworks and the particles in the fireworks. Looking to possibly get noiseless fireworks. Fireworks are used illegally in Cortland and it is a Police/ Code Enforcement problems.

Bonnie Quackenbush spoke stating she is creating an entity called Patchwork (People Acting Together for Community Health). She is working with Deacon Pat Kinney at Grace & Holy Spirit an incredible place that reaches out to the community in many ways. There are a lot of things that they would like to have happen but don't really have to funds to make them happen. There are 9 categories they work on. Green bag ladies, there is volunteer group that is distributing free cloth bags to those who need them. They are at the United Presbyterian Church 25 church street from 10am-12pm on the 1st & 3rd Saturdays of the month. Donation of cloths and items is welcomed. Ward Report:

Ward 1: Traffic concerns where Yong Street meets Cowance Street and has been brought to the attention of DPW. This is the 1st week of glass only recycling collection. A lot of confusion for the pickup of recycling.

Ward 2: There were some concerns with shoveling of sidewalks, concerns with potholes and DPW is filling them as quick as they can. Call DPW or Council member with any immediate concerns. There was a concern about a house on W. Court Street that was sold and is being advertised as sorority house on Facebook and as an event space. The City is aware of this problem and is looking into it. Spam calls seem to be a problem.

Ward 3: Happy with the sidewalk changes but concerned with conditions of some sidewalks. Concerns with W. Court Street house. Glass only first full week of month.

Ward 5: Happy with sidewalks but also questions with conditions of the sidewalks. Concerns with recycling issues.

Ward 6: Quiet. Update on the 40mph on Route 13 to 30mph.

Ward 7: Trash / Recycling issues & concerns.

Ward 8: Notices did not go out to everyone, especially renters. Possibly another notice going out by DPW. Mixed concerns with sidewalks.

Mayor's Report:

Trash pickup is weekly with recycling collection with the first week glass-only and subsequent weeks mixed recycling (no glass). This system was the City's best option regarding cost. This is due to changes made by the County. Stickers should be placed this week on bins that are rejected.
